COLLECTIVE PURCHASE PROGRAM - BASED IN WEST AFRICA, THE ORGANIZATION PLANS TO TRAIN SMALL STORE OWNERS IN RURAL AREAS OF WEST AFRICA TO COLLECT PURCHASE PAYMENTS FOR FERTILIZER AND SEED; FARMER COOPERATIVES ON HOW TO PAY IN ADVANCE FOR FERTILIZER AND SEED PURCHASES; FARMER COOPERATIVES TO USE MODERN PLANTING TECHNIQUES; AND FARMERS ON HOW TO STORE THEIR FOOD/HARVEST FOR LONGER.

WOMEN'S PEANUT PROGRAM - THE ORGANIZATION PLANS TO ENROLL WOMEN IN RURAL WEST AFRICA IN A VILLAGE COLLECTIVE PURCHASE GROUPS WITH AN AVERAGE GROUP GOAL OF THE EQUIVALENT OF \$25 A YEAR TO USE TOWARDS THEIR PEANUT CROPS. UPON REACHING THE GOAL, THE ORGANIZATION WILL TRAIN ON HOW TO PLANT, WEED, HARVEST AND STORE THE PEANUTS.

MEN'S CEREAL PROGRAM - THE ORGANIZATION PLANS TO ENROLL MEN IN RURAL WEST AFRICA IN A VILLAGE COLLECTIVE PURCHASE GROUPS WITH AN AVERAGE GROUP GOAL OF THE EQUIVALENT OF \$100 A YEAR IN TWO PROGRAMS - SORGHUM AND MAIZE. UPON REACHING THE GOAL, THE ORGANIZATION WILL TRAIN THE MEN ON HOW TO USE THE MONEY TO PURCHASE NEW CERTIFIED SEEDS TO INCREASE CEREAL PRODUCTION.
